## **President's Report**

This year, like any other was not without its difficulties, but we 'got there' in the end. Reduced player numbers in the women's teams made life difficult this year for most of the season; and caused some issues with qualifications and team numbers. The men's teams fared better, with no major problems in that area and benefitted from an injection of youth into the teams. Our juniors were again the stand-out performers with an increase in numbers and some great results.

The club continues to focus on developing, and increasing the numbers our juniors. The 'Come and Try' sessions saw a good number of new players join the junior ranks and some good coaching and game time has seen them develop. It was very pleasing to see more of our juniors making a successful transition to senior teams, in both the men's and women's competition. I hope they continue to grow and enjoy the sport at this higher level.

I am very pleased to report that we took advantage of a new SEHA initiative and participated in the 'Whistle Warriors' program, providing training for emerging umpires; and mentoring and development for existing umpires. We should definitely build on this initiative as an ongoing program of development.

Regrettably, we lose Jill Hay as our head women's coach. Jill notified us in the latter stages of the season, that she did not intend to coach at the Club from next season. She will be missed and is proving hard to replace.

Recently, the Club hosted a team from the WA based BMR Coaching Academy. The usual game, plus BBQ was well received by all and a great way for our young people to meet like-minded people they would never otherwise have met.

I have had some personal issues which have diverted some of my attention during this season, and will continue for some time yet. I extend my thanks to my fellow Board members, who have put in a lot of time and effort again this year to progress the Club. Thanks also to the coaches and managers, who continue to contribute to the smooth running of the Club.

Thank you to the Bankstown District Sports Club, the Board of Directors, Marie Kanaan and the Sport and Community team; Josh, Matthew and Shannon, for their support and interest in our club. The Sports Club holds the lease on the Hockey facility and provides us the opportunity to manage it. This provides the funds we need to operate, now and into the future.

## **Treasurer's Report**

Our main sources of usable income continue to be ground hire and canteen sales. Turf hire income was down by 27.4% on last year, due in part to SWHL moving towards a home & away format and playing less games at Bankstown. Canteen income was also down, by 39% (on last year), probably due to fewer games. Overall, total revenue was down 19.3% and expenditure was up by 3.5% over last year. Despite this, the Club remains in a sound financial position and continues to subsidise playing fees for all members and fulfil its obligation to the Sports Club to set aside \$10,000 per year to a 'sinking fund'.

Fees continue to be heavily subsidised, with registration income only covering less than 63% of direct competition related expenses. Presentation day is also heavily subsidised, by about 75% of the actual cost of the event. Fee payment continues to be an issue, with a number of players still with fees outstanding, even at this time.

Repairs were carried out this year on the field watering system, and other minor maintenance continues to be carried out. Attached are the auditor's report, profit and loss statement, and balance sheet for the 2018-19 financial year.

The Hockey Club would like to thank the Sports Club for their continued financial and moral support; it is always greatly appreciated.

## **Men's Convenor's Report**

The 2019 season was a largely successful year for the Men's side of the club. Bankstown hockey entered an additional team into the Sydney Hockey Association competition with the inclusion of both new junior and senior players joining the club. The club entered the teams in the Sydney League 1 (SL1), SL3 and SL5 divisions.

All three teams faced challenges throughout the season as player availability and injury caused numbers to be stretched on multiple occasions. However, all teams developed throughout the year and were largely competitive with the other clubs in their respective competitions.

#### SL1

The SL1 team remained largely the same as the 2018 squad and meant that team combinations were continually developed. This allowed for a much stronger side as all players had at least one season of senior competition experience. Darren Bowman and the senior players within the team continued to develop the skills of the younger players and turned the team into a top side. The juniors within the team continued to show their mettle and proved that they are all capable of playing at this level. The team had a highly competitive season and were unfortunate to lose a couple of key games, narrowly missing out on a semi-final spot. Looking forward to the 2020 season, I believe that this team will be a premiership contesting side in this division.

### SL3

The SL3 team was made up of a combination of experienced players from last year's SL4 side alongside some new players and aspiring juniors. This team was able to compete with all teams in their division but was unfortunate to be the team most impacted by injuries and player absences; often starting games short of players. With support from the other two men's teams they were able to post some strong results and were unfortunate to finish the season in the position they did. Going forward with a similar squad I am sure that this team will be a competitive side provided we have a few more registrations to cover injured players.

#### SL5

The SL5 team was a largely social and developmental side this season with a small number of juniors beginning the transition into men's competition. This team was competitive when however, what they lacked was an experienced mid fielder to guide the team. Overall the team seemed to enjoy their season and the juniors who were supported in this team are keen to continue to develop their skills in the 2020 season.

A big thank you to all the players that backed up and played across the three teams this season. I would like to thank those players that filled in as goalkeepers throughout the season. Jesse Turner was a standout throughout the season, and I can speak for all SL1 players when I say that the development that Jesse has had over the past 12 months has been monumental and largely contributed to the team finishing 5th this season.

Finally, I would like to thank all the players for a positive season played in an excellent spirit. The team development throughout the club is evident and Bankstown Hockey has become a club that

umpires look forward to referee. This had been acknowledged by the Sydney Hockey Association with the club being awarded with the 2019 Sportsmanship award at the Annual Awards night.

### Looking Ahead to 2020

The club plans to nominate three men's teams for 2020 in the SL1, SL3 and SL5/6 competitions. At present most players from this season are planning to play on at Bankstown in 2020. We have also had interest from both new and returning players to join our club for next season alongside a small group of juniors ready to make a transition into senior competition.

Moving forward into the 2020 season I would be encourage each team to nominate a team captain/manager who can assist with the management of players throughout the season.

I would like to take this opportunity to thank all the men's players, coaches, managers and supporters for a great 2019 season. I look forward to the 2020 season and hope that we continue to build on the success of the past two years.
